

Hamlin Town Board Meeting

The Hamlin Town Board held their regular meeting in the Hamlin Town Hall Located at 1658 Lake Road Hamlin, New York. The meeting was called to order at 7:00 by Supervisor Eric Peters. The locations of the fire exits and defibrillator were explained to those present. Everyone was invited to participate in the Pledge of Allegiance and a moment of silence for the deceased residents of Hamlin.

Dear Town of Hamlin Supervisor Eric G. Peters and Town of Hamlin Board,

At the June 11, 2018 Town Board Meeting and in a follow up letter to the Board dated June 14, 2018, I requested that the Town Board identify a decision date to either 1) Permanently Fix the Broken Drainage System at the West End of Newco Drive, or 2) Do Nothing. At the June 11, 2018 Meeting the Board said they would get back to me. As of July 9, 2018, I still await your response.

As you may be aware, I have applied for a DEC and Town Permit to construct a protective flood berm around my property at 8068 Newco Drive as a backup measure. Without the protection of the berm or a long term durable fix of the Broken Drainage System, my property remains in great peril from exposure to rainstorms and runoff. I continue to be both concerned

and very worried about both the short and long term survival prospects for my home and wish to instill and continue a sense of urgency for the Town to act and protect the properties at the West End of Newco Drive.

Of Course, the desired outcome is to Permanently Fix the Broken Drainage System – selecting the best Solution Option and creating a Project Timeline for the earliest completion date possible.

APPROVAL OF LOCAL LAW NUMBER 4 OF 2018:

Resolution #147 Motion was made by Councilperson Martin Maier, Seconded by Councilperson Dave Rose requesting Town Board Approval of A Local Law Adopting Special Provisions Regarding Modification of Site Plans in Commercial Use Districts.

Section 1. Section 520-18 (C-NB District) of the Town of Hamlin Zoning Law of 1991 is hereby amended to add subsection (A)(2.1) as follows:

520-18. C-NB DISTRICT

(A)(2.1): Modification of Approved Site Plan Because of Change in Use

Pursuant to the provisions regarding site plan approval process (see section 520-65(J) of this Chapter), certain requirements for site plan approval may be waived if an applicant merely proposes to change a use permitted pursuant to a site plan previously approved by the Planning Board to another use which is also permitted subject to site plan approval in the C-NB District.

Section 2. Section 520-19 (C-GB District) of the Town of Hamlin Zoning Law of 1991 is hereby amended to add subsection (A)(2.1) as follows:

520-19. C-GB District

(A)(2.1): Modification of Approved Site Plan Because of Change in Use

Pursuant to the provisions regarding site plan approval process (see section 520-65(J) of this Chapter), certain requirements for site plan approval may be waived if an applicant merely proposes to change a use permitted pursuant to a site plan previously approved by the Planning Board to another use which is also permitted subject to site plan approval in the C-GB District.

Section 3. Section 520-65 (Site Plan Review) of the Town of Hamlin Zoning Law of 1991 is hereby amended by adding subsection 520-65(J) as follows:

520-65. Site Plan Review

(J): Special Provisions Regarding Modification of Site Plans for Commercial Use.

1. Administrative Approval of Certain Changes in Use.

(a) With respect to a use permitted by site plan approval in a commercial use district, site plan approval is not required for a change of a previously approved use within a previously approved building or structure provided that there is no change in required parking, site drainage, access, lot coverage, or exterior alteration of the building or structure, and further provided that the proposed new use is also a use permitted subject to site plan approval. Upon a determination by the building inspector that the proposed new use meets all such requirements for exemption

from the requirements for site plan approval, the building inspector shall file a statement setting forth the date of approval of such change in use with the original approved site plan, and may issue a certificate of occupancy for the new use.

(b) If administrative approval of change of use has been issued pursuant to subsection (J)(1)(a) above, site plan approval is also not required for a change in previously approved exterior signage provided that the only change on the approved signs is the designation of the business.

2. Possible Waiver of Site Plan Review by the Planning Board.

All applications for a change of use or for other modifications to a previously approved site plan for a commercial use which do not meet the requirements for administrative approval pursuant to subsection (J)(1) hereof require site plan review by the Planning Board. Notwithstanding the foregoing, upon a finding by the Planning Board following its initial review of the application that, because of the particular character or limited nature of the change in use or modification of site improvements, the submission of a site plan, or of particular portions of the information typically required as part of a site plan, is inappropriate or unnecessary, the Planning Board may vary or waive the requirements for site plan review. The decision to vary or waive the requirements for site plan review shall be incorporated in a resolution setting forth the reasons supporting the decision. When granting a full or partial waiver from the requirements for site plan review the Planning Board may impose additional conditions it deems appropriate or necessary with respect to modification of the site plan. A statement setting forth the date such waiver was granted and the decision to permit the modification requested shall be filed with the previously approved site plan.

Section 4. Effective Date.

This local law shall become effective upon filing with the Department of State.

DISCUSSIONS:

- A discussion was held on 8068 Newco Drive. Highway Superintendent Steve Baase has made improvements on Newco Drive including increasing the pipe size. Resident David Isabella (8068 Newco Drive) is the only resident experiencing issues. The improvements made have lowered the wet land/swamp 14 inches. If the lake gets crazy again it could flood, but everyone down there could flood. Any further improvements will be

extremely costly to the taxpayers. The Easement is owned by the State. The State would need to bring the Easement up to Code before the Town would even consider taking over the Easement. The property was purchased in the wet land, pictures from 1998 show it in the Lake. There was previously a pipe in the neighbor's yard to help drain but the neighbors have revoked town's privilege from entering it to clean out the pipe. The neighbor believes that pipe is no longer there. Moving forward the problem is associated with the property that is part of the wet land. It is not in the taxpayer's best interest to put that much money into the problem of one person's property. It is recommended the resident contact the State since it is their easement.

- A discussion was held on the Tower Lease for 91 Railroad Ave. American Towers current Lease ends in 2025. We have three options. Option 1 is to do nothing and wait until we get closer to the end of the lease. Option 2 is to receive \$30,000 up front with slightly higher increase in monthly payments. Option 3 is to receive \$20,000 up front with bigger monthly payments.

RENEW LEASE WITH AMERICAN TOWER:

Resolution #148 Motion was made by Supervisor Eric Peters, Seconded by Councilperson Martin Maier requesting Town Board approval to send American Tower a letter of intent to renew the lease where we would receive \$30,000 up front with slightly increased monthly payments with the lease agreement being reviewed by Town Attorney Ken Licht.

- Dog Control-Have been very busy, Councilperson Jason Baxter explained he gets notified with each call. Took in two dogs from Penfield one was adopted out. Had an incident where two pitbulls attacked another dog.
- HVA- Still has great coverage rate. Looking to replace one of the ambulances which would cost about \$100,000 which they do not have at this point in time.

Councilperson Jennifer Voelkl reported on the following:

- Zoning board: Public hearing for chickens on Church rd. No one wished to speak and the variance was granted. A Public Hearing was held on moving a Shed on Walker Lake Ontario rd. to a lot that has no primary structure. No one wished to speak and the variance was granted. A public hearing was held on adding a fence to extend beyond front setbacks of a dwelling on Walker Lake Ontario Rd. A few residents spoke on the matter and the variance was granted with some modifications. A Public Hearing was held on demolishing a detached garage and adding an attached garage on Redman rd. No

one wished to speak and the variance was granted. A Public Hearing was scheduled for a resident on Sandy Shores drive for a Shed.

- Chamber of Commerce: Working to get the link on the Town of Hamlin Website.

Councilperson Dave Rose reported on the following:

- Planning Board: Soggy Nova Subdivision Preliminary and Final, BORREGO SOLAR SYSTEMS, INC presented for a large scale Solar Energy System
- Library-Meeting Wednesday
- Senior: Meeting will be held Tuesday. Picnic fourth Tuesday in August

Highway Superintendent Steve Baase reported on the following:

- Start Kendall Waterline tomorrow at 9am. Start Blacktop in Hilton tomorrow at Northwood Elementary. Still replacing culverts.
- Finally got bill for the truck that needed transmission and engine work. It cost \$15,200
- Trying to fix drainage in Tracianne Drive.
- Starting to schedule summer road work
- Mowing has slowed down, but watering flowers a lot more. Working on Cemeteries
- Need to look at replacing or removing fence at the history center.
- No issues with park security

Building Inspector Code Enforcement Officer Cheryl Pacelli:

- 55 permits issued where the cost received was \$4,765 and 19 permits have been closed.
- 296 phone calls into the office.
- Sent out 8 Violation notices
- Working on notifying home owners and property maintenance companies to comply with the code for lawn mowing.
- DEC is still reviewing application for the West Side of Sandy Harbor.

- Attended fire call on Monroe Countyline rd. on 6/17/18

- Final Roll is in.

Librarian Christine Gates reported on the following:

- Summer reading program is going well
- Community participation is great. Mark's Pizzeria was there today

- Attended grant seminar and had a great response for the Mural project.
- Helping with a grant for the playground equipment in Huntington Park.
- Looking for a grant to resurface the tennis courts.
- \$15,000 grant check was received and cashed for the athletic wheelchairs. Working on pricing with Monroe Wheelchair.
- Meeting with the Lions Club in regards to no bathroom access from gym for individuals in wheelchairs.

Conservation Board Chairperson and Town Historian Dave Walch Reported on the Following

- Open hours on Wednesday afternoon
- Researcher coming out to look at an artifact.
- Working on an article for the Hamlin Express.

Supervisor Eric Peters

- Met with Parma, Clarkson, the Village of Hilton and RTS. They have completed their first phase of reworking high frequency routes. The Second phase will be reworking suburban routes. They have not started this phase yet and there will not be any changes until 2020. However there will probably be no local stop in Hamlin. We will see what happens with this.
