Councilperson Jason Baxter reported on the following

- Dog Control- Spoke with NYS Fence, Empire Fence and Steve Speed to get quotes for new kennels. All quotes should be received within a week. They were all provided with 6 drawings. They are going through the delinquent list and responding to calls.
- HVA- COVA-They have still been very busy but have maintained a great response rate. Councilperson Dave Rose reported on the following:
 - Planning Board- Kept the Public Hearing for Solar One LLC open.
 - Library-Received a \$10,000. The State is trying to make it mandatory for the Trustees to take a 3 hr training course yearly that would cost the Municipality each year. The State asked for feedback from Trustees on this grant.
 - Seniors: Everything is going well. The 23rd will be the Halloween pizza party. Tomorrow is the train trip. The seniors are looking into buying the Library a Larger Flag for meetings at the Library.

• Fawn Meadows- Residents had inquired about dedicating the road .We found out Bonding is possible. The residents have changed their mind and are financing themselves through a bank.

Councilperson Martin Maier reported on the following:

- Hamlin Fire District: 508 Calls YTD. Talking about changing the number of house officers. They are researching getting new cameras, but would need to update their server.
- Conservation Board: 2 Referrals.

Highway Superintendent Steve Baase reported on the following:

- Working on a lot of county work
- Milling out housing tracks next week then paving
- Junk Drop off 10/19-10/21
- Brush Pick up-10/22-10/26
- FEMA Turned down Most requests- we did get a \$23,000 reimbursement from FEMA for sandbags. They have okayed a project at Newco and another small project too.

Building Inspector Code Enforcement Officer Cheryl Pacelli reported on the following:
