

**HAMLIN ZONING BOARD OF APPEALS MINUTES
MONDAY, April 17, 2017
7:30 P.M.**

The regular scheduled meeting of the Hamlin Zoning Board of Appeals was held at the Hamlin Town Hall located at 1658 Lake Road, Hamlin and was called to order by the Chairperson, Norman Baase at 7:30 p.m. with the location of the fire exits and AED explained for those present. It was asked that all cell phones and pagers be turned off for the duration of the meeting.

Present: Town Councilperson Jennifer Voelkl, Conservation Advisory Board Member Nathan Pacelli.

Approval of the March 20, 2017 meeting minutes. Additions, deletion, or corrections to tonight's meeting.

A motion was made by Jerry Hoffman, seconded by Phil Hurlbutt to approve the meeting minutes of March 20, 2017 as recorded.

DISCUSSION

Town Councilperson Jennifer Voelkl reported on the following items:

65 Orchard Avenue partially collapsed during the last windstorm. Steve Baase knocked down portions near the collapse to minimize the danger of further collapse into the neighborhood. The issue of the asbestos on the roofing material is still being discussed. As a result of the collapse the asbestos from the roofing material is now spread over a larger area. The Town of Hamlin donated \$1,000.00 to the Pen Rearing Project to assist in the purchasing of new nets and feed. The Sandy Creek Shoot Out will be held on July 29, 2017.

The Free Rabies Clinic will be held on May 19, 2017 from 6-8pm at 93 Railroad Avenue, Hamlin.

It has been reported that the level of Lake Ontario are 2 feet higher than expected. Sodus Bay (started sand bagging) and Irondequoit Bay are also experiencing high lake levels.

The Zoning Workshop will be held on April 20, 2017 at 7:00 pm.

Conservation Board Member Nathan Pacelli reported that the Free Tree Seedling Event will be held on Saturday, April 22, 2017 from 9:00am-12 noon at the Town Hall Parking Lot.
