#### Jeanine Klopp reported on the March 1, 2021 Planning Board Meeting.

There were 3 items on the agenda:

**6386 Shore Acres Drive** for Jennifer Voelkl. A new sump pump under the dwelling in the crawl space and piping out to the lake thru the existing breakwall to dispose of excess ground water. The DEC stated it was non-jurisdictional as long as the rock revetment was not altered for the placement of the pipe. The Town Engineer inquired about the angle of the piping. This is a Type II SEQR. The Conservation Corridor Development Permit was granted.

**7572 Sandy Harbor Drive** for Vince & Cindy Harper. To add a screen room addition onto an existing deck on the north (lake side) side of the dwelling. The Conservation Corridor Development Permit was granted.

**3069 Roosevelt Highway** for John Rachow. It consisted of moving the existing side lot line between 3069 & 3053 Roosevelt Highway to make both lots a more consistent size. The amended site plan was approved.

**Under Discussion:** The LWRP meetings have started. They should be the 2<sup>nd</sup> Thursday of each month. The meetings will be either in Zoom or in person. At the Zoning Workshop, battery storage is on the agenda. There was a resolution for the sewer district.

# Steve Rutherford reported on the March 8, 2021 Fishing Advisory Board Meeting.

## Clarke Mahaney reported on the March 8, 2021 Town Board Meeting.

County Legislator – Jackie Smith gave an update on COVID vaccines. If seniors are in need of a COVID vaccine, they can call Lifespan at 244-8400. Any veterans still needing the vaccine can call Rochester Caulkins VA Clinic at 463-2600. The Genesee Valley Nurses Association is helping homebound seniors, reaching those in the meals on Wheels program and others that may not be in any programs. In February the Monroe County legislation oases "Maisie's Law to combat opioid overdoses. Pharmacies in Monroe County would be required to inform prescription opioid patients that the opioid overdose drug naloxone is available to them. Jackie is working hard on protecting operation hours of the Erie canal. Our community depends on its tourism, recreation, history and education of the Erie Canal. Jackie also wanted to thank the Town Clerks office for the assistance of the Community Hygiene Bank. Please refer to the Town Board Minutes of March 8, 2021 for further information on that meeting.

## Cindy Lutwiller reported on the March 15, 2021 Zoning Board of Appeals Meeting.

**Public Hearing - 9625 Beachwood Park** for Rebecca Schicker and Steve Denero. They have been before the board several times for discussion on a shed that was built without a permit and on what appeared to be a portion built on a neighbor's lot. A new site map was provided that showed a boundary agreement from 2019, the year they purchased the property. This map was provided after the legal notice was submitted for print. The Public Hearing will be left open and the application will be revisited with boundary agreement on April 19, 2021 after 7:30pm.

**Public Hearing - 388 Walker Road** for Kim Hawkins. This is for a fence height variance. There was no one present to represent the applicant. The Public Hearing will be left open and is scheduled for April 19, 2021 after 7:30pm.

**Public Hearing – 8 Lake Road East Fork** for Vincent Rovitelli. He is seeking a variance for 99 parking spots and to pave the apron ingress/egress only at the marina. These variances were granted.

**Public Hearing – 6390/6394 Shore Acres Drive** for Thomas Brennan. He is seeking a Coastal Erosion Hazard Area Variance to raise a cottage in the CEHA area and not have to move it 25-feet landward. There was discussion of also a proposed porch to be added to the east and the south sides of the cottage. The CEHA Variance was granted for the raising of the existing cottage using the same footprint in the CEHA Area.

**Agenda – 410 Hamlin Center Road** for Frederick & Kris Armes. They are seeking side & rear setback variances for a 24 x 40 barn/outbuilding to be placed in the rear yard. This application is scheduled for a Public Hearing on April 19, 2021 after 7:30pm.

**Discussion:** Town Board Liaison Jennifer Voelkl reported the following: There is a new fee for 3<sup>rd</sup> inspections by the fire marshal. The Zoning Board Workshop will discuss battery storage at solar facilities. There was a resolution for the sewer district. Kendall appears to be 4-6 months behind Hamlin in the sewer process.

## Jeanine Klopp reported on the Friends of Hamlin Beach.

Camping will open on May 14, 2021. At this point, camping at all NYS parks is by reservation only.

Shelters can be reserved, with limited capacity, beginning on May 14, 2021.

No summer concerts have been scheduled at this time.

I Love My Park Day is Saturday, May 1, 2021 from 9 am - 11 am. Due to Covid restrictions the number of participants is limited to 50 and masks must be worn. On-line registration is required beginning in April at ptny.org/ilovemypark.

## Town Board Liaison Jason Baxter reported on the Zoning Workshop

The Zoning Workshop sent the rental law back to the Attorney to look at the revision suggestions that were made. There will not be a moratorium on battery storage as developing a code is faster. The following items will be discussed

on a path for a new code: How and where to charge batteries for when the sun is not out. The power would be stored in the batteries for use when there is no sun or it is raining. Take a look at properties to determine if re-zoning is required. How much space the batteries may take up in the build. The possibility of explosion, fumes, odors and proper ventilation. Look to see if there might be inspections required by the fire marshal. Look at the distance of solar facilities to the substation.
